## TAX CREDITS AND HIRING INCENTIVES

The federal and Maryland state government offer numerous tax credits to businesses hiring targeted populations. In addition, Anne Arundel Workforce Development Corporation (AAWDC) offers assistance to local businesses hiring individuals meeting defined criteria. Our knowledgeable staff can help you navigate the options available to your business.

### FEDERAL WORK OPPORTUNITIES TAX CREDIT (WOTC)

WOTC is a tax credit to businesses hiring targeted populations. Employers can receive up to 40% of the employee's wage, capped at up to \$12,000. For details, visit <http://www.doleta.gov/business/incentives/opptax/>. Targeted populations:

- ▶ Recipients of Temporary Assistance to Needy Families (TANF)
- ▶ Disabled Veterans or Veterans Receiving Unemployment
- ▶ Youth Age 16 to 25 Who Are Out of School and Unemployed
- ▶ Vocational Rehabilitation Referrals
- ▶ Ex-Felons

### MARYLAND TAX CREDITS

Anne Arundel County businesses may be eligible for Maryland hiring tax credits. For details, visit <http://business.marylandtaxes.com>. Workforce credits include:
